Parents elect to pay tuition on either the 5 th or 20 th of these months through the H.L.T.M. Service. Roger Bacon will assess an additional finance charge on both the semester and quarterly payment options. |
| Option 3 | 11 Monthly Payments through H.L.T.M. Service. These payments will be electronically debited from the designated account on either the 5 th or 20 th of each month through the H.L.T.M. Service. The first payment month is July. Roger Bacon will assess an additional finance charge on the 11 month payment option. |
